**ORDER**

**No.6/5/2015-TUFS:** The Revised Guidelines of ATUFS i.e. financial and operational parameters and implementation mechanism during its implementation period from 13.01.2016 to 31.03.2022 was notified vide Revised Resolution dated 02.08.2018. The following modifications are hereby notified in the said Revised Resolution with the approval of Competent Authority:

- (i) The word **"and Embroidery including Standalone Embroidery Activity"** is inserted after the word 'sewing machinery' in para 2.6
- (ii) The word **"Embroidery including Standalone Embroidery activity, Made-ups"** is inserted at Sl. No.1 in table below para 4.1.

Note under Para 4.1 : Standalone embroidery units are eligible for subsidy for purchasing embroidery machines on standalone basis under ATUFS for 15% CIS for which loan sanction date is on or after 27.02.2019

- (iii) Para 3.4 to be read as **"Textiles Commissioner has been authorized to approve the indicative list of machinery manufacturer and listing in the website subsequently. The list so uploaded will be ratified in subsequent meeting of TAMC"**.
- (iv) The sentence "In such cases, the Technical Committee mentioned para 3.4 above will verify those manufacturers and machinery and if found suitable, propose their inclusion in the indicative list of manufacturers by the TAMC" in para 3.5 is to be read as **"In such cases, those manufacturers, if found eligible, will be enlisted by Textiles Commissioner and ratified by TAMC"**
- (v) The word **"machinery"** in 4<sup>th</sup> line of Para 10.2.6 of the revised guidelines is to be read as **"machinery manufacturer"**. The words **"in the next monthly meeting of the Technical Committee. This exercise along with the approval of the TAMC should get completed within 45 days"** in para 10.2.6 is replaced by **"by the Textile Commissioner which will then be ratified by TAMC. This exercise should get completed within 45 days"**.
- (vi) The word **"Supplier(s)"** stand deleted from 2<sup>nd</sup> line of para 3.3, 3<sup>rd</sup> & 4<sup>th</sup> line of para 10.2.2 and 4<sup>th</sup> line in para 10.4.3.
- (vii) The words **"beyond one year"** in 2<sup>nd</sup> line in para 10.2.5 to be read as **"upto one year beyond the initial prescribed period of one year"**
